- 2. December 6, 2022 LG minutes approved as written.
- 3. December 18, 2022 Congregational meeting minutes Discussion re: congregational meetings at 7pm vs second hour. Different times reach different groups of people which has its advantages. Approved as written.

Discussion/Action

- 4. Spending Plan (Larry, John and Dancy). Pledges are 83% of the proposed spending plan. Insurance prices are increasing, which will change the budget slightly. The biggest change was getting the Mission of Assembly back to what it was in 2019. There is an MYF increase due to the convention next year. Building tithe is added back in. Cost for church retreat was also a big increase. Discussion re: confusion of having a Members Need fund plus a Members Need line item. LG recommends not having a separate Members Need fund. Finance Committee to make final decision. Also, LG recommends sometime in the 4th quarter a reminder of where they are in their pledging be sent to all those who have pledged. An email will be sent to all pledgers in January explaining this. There is roughly a \$6000 deficit for 2022 that will come out of the surplus. Definite number still forthcoming.

Historically, Assembly has allowed pastors to designate up to 100% of their salary. Randy Roth proposes to allow pastors to designate up to 100% of their 2023 salary. Sandy seconded. Motion passed.
